I understand and acknowledge that no refunds will be granted;

I irrevocably grant unlimited permission to the Releasees to use, reproduce, sell and distribute any and all photographs, images, videotapes, motion pictures, recordings, or any other depiction of any kind of me, of my participation in the event(s) "Beat The Bog", for any legitimate purpose in perpetuity, and I understand that I shall not be entitled to any compensation therefore;
